

## AUO Privacy Policy for Korean Residents

This Privacy Policy for Korean Residents (“Policy”) is part of AUO Corporation’s Privacy Statement (“Privacy Statement”) and should be read in conjunction with it. This Policy is made pursuant to the Personal Information Protection Act (“PIPA”) of ~~Korea and other laws and regulations regarding data protection~~.

If there is any inconsistency between this Policy and the Privacy Statement, this Policy shall prevail.

### Items of Personal Data we Collect and Legal Basis for such Processing

~~Notwithstanding “Our collection of personal data” and “What is our lawful basis for processing your personal data?” of the Privacy Statement, we process your personal data (including last name, first name, e-mail address, job title, company name, card country/region) based on your consent (PIPA Article 15(1) (i)) for the purpose stated in “How do we process your personal data?” of the Privacy Statement. Other than the foregoing, we do not process any other personal data pursuant to any other legal bases.~~

### Retention Period of Personal Data

Notwithstanding “How long do we keep your personal data?” of the Privacy Statement, if required to retain personal data pursuant to applicable Korean laws, such as those set out below, we will retain personal data for at least the retention periods and purposes prescribed.

- Records related to labels and advertisements: ~~6 months (as required under the Act on Consumer Protection, etc. in E-commerce)~~
- ~~under the Act on Consumer Protection, etc. in E-commerce)~~
- ~~Records on e-commerce: 3 months (as required under the Communications Secrecy Protection Act)~~

### Transfer of Personal Data

You and your legal guardian may also exercise your right of withdrawal for consent to processing of personal data, and the right to request an explanation of, or to object to, automated decisions.
